GENERAL

Plumbing work shall not be started until a permit has been issued. All installations shall be in conformance with the State Plumbing Code. No work shall be concealed until it has been inspected and approved.

EXPIRATION OF PERMIT

A permit shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing the work.

A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX (6) MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION.

CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.

FEE CLARIFICATIONS

MOBILE HOME UNIT SITE:

When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites.

When setting a mobile home in a park, or a mobile or modular home on private property, a permit should include the application fee, a sewer or building drain, and a water service or water distribution pipe.

REINSPECTIONS AND FEES

Reinspections are required when the inspector is locked out; when the work is incomplete or when code violations exist that require a reinspection. A reinspection fee of \$50 will incur each occurrence.

PLAN REVIEWS

Plans and specifications for new construction work, alteration, repair expansion, addition, or modification work shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended, and shall bear that architect's engineer signature and seal. A PLAN REVIEW IS REQUIRED BEFORE A PERMIT CAN BE ISSUED.

- Exception 1: Alterations and repair work determined by the plumbing inspector to be of a minor nature.
- Exception 2: Work completed by a governmental subdivision or state agency costing less than \$15,000
- Exception 3: A building of use group R-3 or R-4 containing not more than 3,500 square feet of building
 - area.
- Exception 4: Repair or alteration to an plumbing system that costs less than \$10,000 unless requested by administrative authority.
